What the Policy covers?

This Policy protects Plant and machinery owned by you against sudden & unforeseen physical damage by any cause or peril which are not specifically excluded under the policy.

What the Policy does not cover?

Your policy does not provide coverage for loss or damage resulting from:

- loss or damage due to electrical or Mechanical breakdown, failure, breakage or derangement, freezing of coolant or other fluid, defective lubrication or lack of oil or coolant
- loss of or damage to replaceable parts and attachment such as bits, drills, knives or other cutting edges, saw blades dies, moulds, patterns etc
- loss of or damage to vehicles designed and licensed for general road use
- loss of or damage to Hull and machinery of waterborne vessels or crafts, however this exclusion shall not apply to CPM mounted on water borne vessels or crafts for the purpose of use for the contract work.

- loss or damage whilst in transit, from one location to another location
- loss of or damage to plant and/or machinery working underground.
- wear and tear, Faults or defects existing at the time of commencement of insurance which ought to have been or were known to you, Faults or defect for which the supplier is responsible either by law or under contract
- war & Nuclear Group of Perils
- earthquake
- willful acts or Gross negligence on the part of you or your representatives

Dispute Resolution

Raheja QBE will take all steps to settle your claim in accordance with policy terms and conditions. However, since the policy does not cover all eventualities, there may be disagreement on settlement of the claim.

For resolution of such disputes Raheja QBE has developed an elaborate grievance redressal mechanism.

At your request, the claim will be considered afresh by the Grievance Committee of Raheja QBE. If you are not satisfied with the decision of the Grievance Committee you may refer your case to the Insurance Ombudsman. Please call Raheja QBE offices to ascertain if you are eligible for such a reference.

SECTION 41 OF INSURANCE ACT, 1938

No person shall allow or offer to allow either directly or indirectly as an inducement to any person to take out or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate except such rebate as may be allowed in accordance with the published prospectuses or tables of the Insurer.

Any person making default in complying with the provisions of this section shall be punishable with fine, which may extend to Five Hundred Rupees.
